Annual Registration Scheme (ARS) 2019-2020

Dear Member,

We are pleased to inform you that the Managing Committee of Ernakulam Branch of SIRC of ICAI for 2019 -2020 has decided to continue the Annual Registration Scheme (ARS) for the year 2019 -2020 also.

Over the years, the scheme has become popular and has been beneficial for both the Members as well as the Branch.

For the Members, it is a considerable saving financially and it obviates the inconvenience of individual registration for each programme.

With the increase in CPE Credit requirements for the rolling period of 3 years (2017-2019) from 90 to 120 for practicing CA's and from 45 to 60 for Members not holding certificate of practice, it would be necessary for members to plan in advance to meet the above requirements. Since 2019 is the last year of the present rolling period, it is all the more important for members to plan & meet their CPE requirements.

Accordingly, the Branch plans to conduct quite a number of seminars and meetings on varied topics such as Taxation, Company Law, Auditing, Accounting Standards, Bank Audit etc.

In addition, special topics could be arranged based on suggestion from honorable Members.

The ARS is applicable w.e.f 4th March, 2019. The ARS fee has been fixed at Rs.9000/- plus GST and will be open till 15th May 2019.

An early bird discount of Rs.500/- is offered up to 10th April 2019

As done in the previous year, the Managing Committee has decided to give a special reduction for the following categories of members.

Please note that a portion of the ARS amount is set apart for two non-educational programmes, being the family get-together in connection with the installation function of the new office bearers and the CA Day celebration.

Also, please note that ARS scheme will not cover, programmes organized jointly with other branches, Regional Councils / Central Council, teleconferences, workshops and residential seminars / courses; however, discount upto 25% will be offered for registration for all workshops conducted by the Branch.

Members are requested to make use of this special opportunity. The special schemes for organizations are applicable to corporate, as well as Chartered Accountancy firms.

We request you to return the attached registration form duly filled in and signed along with the appropriate payment by cheque / DD drawn in favour of "Ernakulam Branch of SIRC of ICAI" before 10th April 2019 to avail the **early bird discount rates**. Thereafter, the normal rates shall apply till 15th May 2019. Members who have not paid ARS before 10th April 2019, have to make payment for the programmes attended between 04.03.2019 and 10.04.2019 and also must pay the appropriate amount for continuing ARS.
